To ensure that your child's registration is processed without undue delay, please read and sign terms and conditions on the back of this form.

## TERMS AND CONDITIONS

### 1) Registration and Payment:

**a) Registration:** Minimum \$100 deposit (non-refundable) per camp week required by registration deadline to reserve a spot in the above selected camp(s). Your spot will not be reserved unless and until your deposit is received by MTN prior to the above registration deadline. Your child will not be permitted to participate in the camp(s) until payment(s) (includes payment plan option) are received by MTN. All payments are non-refundable and non-transferable.

**b) Additional Fees:** (i) *Lunch Program:* You acknowledge to pay for the lunch services and you must pay for the entire week. We do not accept daily payment. (ii) *Extended Care:* Applies to drop off and pick up outside the normal camp schedule hours as indicated. Coverage is applied from 7 am to 5 pm. Additional fees apply after 5 pm. (iii) *Photo/Video Package:* This package provides a CD disc with photos and videos taken during the on-ice portions during the selected week of the camp. (iv) *1:1 On-Ice Training:* Apply only to the Full Day Goalie Camp. Your child will train 1 on 1 with an instructor at each station during the on-ice sessions.

**c) Multiple Week Discount:** Save \$100/week of camp when you register for four (4) weeks or more of the selected indicated camp(s). This discount only applies to the full day option. It is not available for the half day option.

**d) Payment:** MTN accepts credit cards, cash and/or cheques. If paying by cheque, please make cheque payable to **MTN Goaltending**.

**2) NSF Cheques:** You hereby acknowledge and agree that you are responsible for all fees assessed by a financial institution in connection with NSF cheques. In the event that your cheque bounces, your child will not be permitted to participate in the camp(s) unless and until payment in full in full plus NSF fees are received by MTN.

### 3) Cancellation Policy:

**a) Cancellation due to Injury/Illness:** If you must cancel because your child cannot participate due to injury or illness, you will be entitled to a full refund **except** the deposit of \$100, which will be transferred to a future camp, as long as your child did not participate in the camp(s). In the event that your child must miss more than one (1) full day of the camp, you must provide a doctor's note in order to be eligible for a refund. If your child has started any of the camp(s) and sustains an injury or illness, the fees for the camp(s) will be pro-rated for the days your child has attended and the remaining balance be transferred to a future camp.

**b) Cancellation due to Schedule Conflict:** In the event of a conflict with a scheduled camp(s), you must inform MTN in writing at least two (2) weeks prior to the scheduled camp(s) that your child will miss. No refund will be provided in the event that you failure to provide such notice. So long as you have provided sufficient notice, your child may transfer the camp(s) to other weeks, provided we have sufficient space for your child. You are prohibited from doing a select number of days of one week and use the remaining days for another week. If this arises we will charge the full week price, irregardless of the numbe of days you attended during the week.

**c) Transfer:** If your child is unable to attend a camp(s), you may sell the camp(s) to a third party provided you notify MTN in writing at least two (2) weeks in advance. Failure to do so will result in a penalty of 50% of fees associated to the camp week(s) being transferred.

**d) Lateness:** There are no refunds or credits if your child is late for a camp.

**4) Release:** MTN is not responsible for any injuries sustained during any of its hockey training services or for lost or stolen items. You hereby defend, indemnify and hold harmless MTN and its officers, directors, shareholders, agents, employees and contractors from and against any and all claims, damages, losses and/or injuries incurred by participants in connection with any MTN camp(s).

**5) Permission for pickup of Children:** It is assumed that either parent is allowed to pick up and drop off their children. If you want to authorize anyone else to pickup your child, you must provide us with a signed authorization letter. You agree to report to the daily attendance staff when dropping off AND picking up your child.

**6) Safety:** In order to ensure a safe and enjoyable experience for all participants, MTN requires that every child show respect for their peers and supervisors. For safety reasons it is also required of participants to follow rules and instructions from the monitors.

**7) Medical Emergencies:** You hereby authorize MTN personnel to provide aid to your child in case of emergency. You acknowledge and agree that ambulance transportation costs, in the event of emergency care, are payable by the parents or tutors/guardians.

**8) Authorization:** You hereby acknowledge that you are the parent and/or legal guardian of the child being registered and you hereby authorize your child to participate in activities held by MTN

**9) Consent to receive information:** You hereby consent to receive emails from MTN regarding promotions, special offers and other information.
